1. Eligibility Criteria:

Post:	Field Technical Resource Person(FTRP)
Profile:	Field Technical Resource Person(FTRP) <u>Note:</u> The candidates engaged as Apprentice will NOT be treated as “employees” of the Bank and will not be entitled to receive any benefits which are available for the employees of the Bank.
Qualification:	1. Bachelor's degree/B.Tech E.C.E 2. The candidate should be proficient in Telugu & English Language (Reading & Writing).
Date of Reckoning for eligibility:	All the eligibility (Age, Qualification, etc.) shall be computed as on 01.08.2025 . (inclusive)
Age:	Minimum 20 years and maximum 28 years as on the date of reckoning for eligibility i.e., Candidates must have been born not earlier than 01.09.1996 and not later than 01.09.2004 (both days inclusive).
Period of FTRP Training:	One Year

Test of local language:	Candidates who produce 10 th or 12 th standard mark sheet/ certificate evidencing having studied the specified opted local language will not be required to undergo the local language test. For other candidates, the test for knowledge of local language will be conducted as a part of selection process. It will be conducted when the candidate is called for Document Verification by the Bank. Candidates who fail to qualify this test will not be engaged as apprentice.														
Physical/Medical Fitness:	Engagement of Apprentices will be subject to his/her being declared medically fit as per the requirement of the Bank.

2. Salary:

The Bank will negotiate the salary of the FTRP depending upon the previous experience at the time of Document verification of the candidate. The selected candidate is eligible for other allowances/benefits maximum limit to 5000/-.

3. Selection Procedure:

- The candidates shall be required to submit the duly filled in application (enclosed) directly or by Post at the following address:

- The merit list of those candidates who have applied will be prepared District wise in descending order on the basis of marks/percentage obtained in Graduation. In case more than one candidate is having the same percentage, such candidates will be ranked according to their age in descending order in the merit.
- The selected candidates as per the Merit List shall receive communication from The Krishna District Central Cooperative Bank Ltd to appear for Documents Verification (DV) at Head Office in Machilipatnam.
- Merit list shall be prepared only on the basis of the information filled by the applicant in the application. In case of any discrepancy observed at the time of document verification, the applicant will be disqualified summarily..
- Mere eligibility does not imply that the Bank is satisfied beyond doubt about the candidate's eligibility and shall not vest any right to a candidate for engagement / selection. Bank reserves the right to change / modify the selection / engagement criteria, if necessary.
- All candidates who are finally selected will receive an email communication from KDCC Bank Machilipatnam.

4. Other Terms and Conditions

- (a) It shall neither be obligatory on the part of the Bank to offer any employment to any FTRP who has completed the period of his tenure nor shall it be obligatory on the part of the FTRP to accept an employment.
- (b) Candidates shall be relieved from the Bank after immediate completion of FTRP period. The FTRP will have no right to claim for regular employment in the bank
- (c) The candidature of the applicant would be provisional and subject to verification of documents subsequently. At any stage, if it is found that the candidate has furnished false or incorrect information, then the candidature is liable for cancellation of engagement.
- (d) Candidate seeking age relaxation should submit necessary certificate(s) at the time of engagement and as and when required.
- (e) The engagement of selected candidates will be subject to their being declared medically fit by a duly qualified medical practitioner engaged by the Bank or subject to production of medical certification from MBBS Doctors or both as per the discretion of the Bank.
- (f) Document verification will be conducted by the Bank officials and final selection will be subject to satisfactory verification of candidates' character, antecedents and caste validity certificates (wherever applicable). Till such time, their engagement will be provisional.
- (g) Any resultant dispute arising out of this advertisement for engagement of FTRP will be subject to the jurisdiction of courts in Vijayawada.
- (h) Any disagreement or dispute between the Bank and the FTRP arising out of contract shall be referred to the Bank Legal Advisor.
